1. It was m/s Kennedy/Lopez that the minutes of the LAFCO meeting on August 21, 1984 be approved as prepared.

County of Madera - Proposed County Service Area (Cascadell Woods)

This proposal was continued from the August 21, 1984 LAFCO meeting. The Assistant Administrative Officer sumarized and further explained the proposal.

The Chairman then continued the Public Hearing.

Ron Smith, chief proponent, commented on the proposal, and supported the staff comments:

John Jamison, attorney for the proponents, discussed and explained the background of the Cascadell Woods subdivision, and the recreational areas.

Brian Curtis discussed the proposed service area and the out lots that surround the subdivision.

Jack Hansen, supported the service area proposal and requested that the Commission approve the proposal as submitted.

Ray Brickey supported the service area and wants to have the open space area remain a recreation space.

Jerry Bishop spoke in favor of the service area.

No opposition to this proposal was received from the audience.

The Chairman then closed the Public Hearing.

It was m/s Kennedy/Lopez that the formation of County Service Area - Cascadell Woods be approved as revised, and that the proponents be authorized to proceed in accordance with law, and that LAFCO Resolution No. 84-8, so stating, be adopted, upon the following conditions:

- a. That the proposed service area be authorized to perform only the specific services that are designated in the petition for formation.
- b. That the boundaries of the proposed Cascadell Woods County Service Area be approved as amended by the Commission at their October 16, 1984 meeting.

## 3. Clayton Water District - Proposed Triangle T Annexation
