Water Company News

Water System Recently Violated Drinking Water Standard

Following the required monthly monitoring for coliform bacteria, Cascadel Mutual Water Company (CMWC) members were notified that test results showed the presence of coliforms. Coliforms are bacteria, which are naturally present in the environment and used as an indicator that other, potentially harmful bacteria may be present, and is also a warning of potential problems. <u>At no time was there</u> <u>any presence of E. coli or fecal coliform.</u>

What was done?

The system and storage tanks were thoroughly chlorinated and flushed as of Tuesday, February 23. The chlorine was flushed from the system after 24 hours.

The chlorinated water was not safe to drink; however, it could be used for non-consumptive purposes. Bottled water was provided to full time residents.

The CMWS was resampled on Friday, February 27. Results were made available on the 28th and no coliforms were present. Members may now safely drink the water. CMWC thanks everyone for their patience and understanding while corrective actions were taken. Thanks also to Brian and Ken for quickly implementing those actions. Escaped Burn Pile

On February 24, an escaped burn pile started a small fire off Cascadel Drive. A timely call by the landowner and prompt response by Cal

Fire Engine 4255 (Rancheria Station) stopped the forward progress of the fire within 10 minutes of their



arrival, according to Sierra News Online. Their efforts along with Cal Fire Engine 4285, one Mount Bullion Crew, USFS Engine 52 and Madera County Fire Engine 11 kept the fire to less than a ¹/₄ acre in size. Firefighters stayed on scene for several hours to make sure the fire was dead out. <u>Residents are reminded to</u> follow all instructions on your burn permit, construct a fire line around your piles and do not burn when it is windy.

CSA-21 Lands

Our Supervisor, Tom Wheeler, said that the County is exploring its options regarding their desire to sell the CSA-21 property. Since this property is a benefit to all property owners, not only in recreational & property value but also as a shelter-in-place during a wildfire emergency, this proposed action by the county is raising many concerns.

The MAC committee has announced that they intend to resign after the March 5 meeting scheduled for 10:00 am at the clubhouse. In the interim, the county has approved the use of the clubhouse for the CWPOA, Fire-Wise and Children's Art Class events already scheduled through March.

clubhouse.


