SCHOOL FIRE IN NORTH FORK

On July 10 at 5:24 PM, a fire was reported on the northeast corner of Road 225 and Road 274

There were 170 personnel assigned to the incident from Cal Fire, Sierra National Forest and Madera



County Fire. This included 12 engines, 5 ground crews, 2 dozers and 3 water tankers. Air resources were released.

Dozers cut a fuel break and at 6:47 PM the



forward progress was stopped. At 8:25 PM the fire was reported to be 12.11 acres and 50%

containment. By Wednesday July 11 at 9AM the fire was reported to be at 90% contained. Another excellent job by all first responders.

Carol Eggink would like to thank the mystery weedeater's out there. Easements are being reduced of ladder fuels and Carol, as well as many residents, are very grateful for the help. Tom Wheeler has hired a three man crew from Madera to mow the remaining fields of the CSA grounds. We are told the cost will not exceed \$5,000 from the CSA-21 funds.

CWPOA

The CWPOA is in the process of applying for another grant through The California Fire Safe Council.

We are very excited to be able to include our neighbors in Cascadel Heights and Mr. Morgan in this grant.

The residents from the Heights have been very involved with fulfilling necessary requirements for their inclusion.

We hope to make this entire area as safe as possible to prevent the loss of any more homes in the event of another Wild Fire.

Road Repair

We received 15 tons of asphalt patch and will begin filling pot holes and uneven surfaces on Friday July 27.

THE FERGUSON FIRE

The fire started on July 13 at 8:30 PM. As of the evening of July 25, there are 3,686 personnel assigned to the incident including 241 engines, 94 crews, 47 water tenders, 63 dozers, 18 helicopters, and fixed-wing tankers as conditions allow. The fire is 41,576 acres, with much of the push on the southern perimeter. The fire is 26 percent contained. Yosemite Valley and Wawona are closed to the public. The closure is expected to last through Sunday, July 29. Highway 120 east and west remains open, along with Tuolumne Meadows. For information on Yosemite National Park, go to nps.gov/yose or call 209-372-0200. There has been one fatality so far. On July 14, Braden Varney a Cal Fire Heavy Fire Equipment Operator Braden Varney from the Cal Fire Madera-Mariposa-Merced Unit was tragically killed," Braden was only 36 years old and leaves behind a wife and two children. The smoke in the air has been quite bad.
