FROM THE CMWC BOARD

Water Company Road Assessments Update

Effective September 1, 2018, with membership approval, the Water Company assumed road maintenance responsibilities and collection of the proportional assessments for that work. We would like to provide everyone with an update to those efforts. Recent weather conditions required maximum effort to keep our roads open.

The year-to-date expenses to operate and maintain our snowplow including fuel, repairs, registration, insurance and labor, totaled \$ 3,829. The cost of road repairs, culvert clearing, and maintenance of the dirt road portion of Cascadel Road required contractor labor & material, extra road fill material and liability insurance totaling \$14,799, for a grand total of \$18,628, with most of these expenses occurring in February and March.

Our Road Committee, led by Director Ed Rose, has identified six road projects estimated to cost \$14,650 and six additional projects with costs to be determined. One of these undetermined projects is the repair of the concrete weir (low water crossing) located at the cascades.

Historically, a point of contention with Property Owners regarding road assessments has been that some owners have not always paid their fair share of road expenses. (There still remain uncollected road fees previously assessed by the CWPOA). Regardless, we are very pleased to report that since the Water Company's start of road assessments to its members, there are only two who are not current on this year's assessments. Only 3 of the 28 property owners, who are not members of the Water Co, are currently past due on road fees. All delinquent water and proportional road expense accounts will be reviewed by the Board at their meeting on March 12.

ROAD WORK

As happy as we all are regarding the snow pack in the high country and the amount of rain we have been

fortunate to have this season, it has taken a toll on our old mountain roads. As reported in the article from the

CMWC Board, there have been many areas repaired to keep up with the damaged caused by this seasons weather. Water berms and water flow diversions were



created to assist the flow of water away from Cascadel Road as well as some culvert clearing.

There were pot-hole repairs along Cascadel Drive and other areas. On March 12, 2019 five buckets of material were used on the paved roads and almost two buckets were used to fill holes on Cascadel Road. The board thanks you for making this possible.



FIREWISE COMMITTEE/BRIGADE

The Fire Brigade held two work days in March. On one day, the Brigade cleared around and flushed most of the



due to the heavy rains from February and March. This hydrant was dug out; sand bags were filled and placed around the backside of the

fire hydrants in Cascadel Woods. This project will be completed in April. One hydrant on Cascadel North was nearly covered in dirt



hydrant to protect it temporarily until a permanent solution is installed.

The second Fire Brigade work day project entailed the

testing of 12 - 1" fire hose for leaks. The new adapters and nozzles were also tested. The hoses came out of storage and will be added to our five fire boxes. There were other duties performed



on the hoses and boxes to make them ready for use. A 150 ft length of 1" hose was placed in the 90° culvert ravine near Joe and Karen Balog's home. The Balog's agreed to allow hook up on their property for use in case of fire in this area.

Dog Control & Leash Law Enforcement

- All dogs in Madera County are expected to be under control at all times.
- They must be confined to your property. If you take them off your property, to go for a walk for example, they must be on a leash.
- Any dog found running at large can be impounded at the County Shelter or returned to its owner with a citation.
- Dogs picked up in violation of the leash law may be redeemed at the shelter at 14269 Road 28 in Madera.
- Dogs brought in without identification are held for three (3) working days.
- Dogs with ID or known owners are held for ten (10) working days.
- Dogs unclaimed at the end of the holding period are available for adoption to responsible homes or can be euthanized after this time.
