It has just been verified by Madera County that the County is working to dissolve the CSA

What this means for the property owners is at present, the open space, pond and clubhouse are under the County Service Area (CSA) through the Local Agency Formation Commission (LAFCO). You are assessed \$100 per year on your property tax bill for the maintenance of the recreation property. If the CSA is dissolved, it is uncertain at this time what the County intends to do with this property. This is still to be determined. Regardless, the County must notify you once a resolution has been made by the Board of Supervisors regarding their intentions and make available to you the option to attend a public hearing at a future date to hear the County's position. You will also have the opportunity to vote on this issue in a process similar to the RMD vote of 2012. The CWPOA will send any additional information to you.

Grants

The CWPOA recently received a \$33,000 fuel reduction grant from PG&E. This funding is provided to help communities near PG&E infrastructure reduce their fire risk and fuel loading. The work will be contracted locally and will begin in June. Thank you to residents who have returned completed release forms for work to be conducted on your property.

The CWPOA, in partnership with the Yosemite Sequoia Resource Conservation and Development Council (YSRC&DC), recently applied for \$50,000 in fuel reduction funding through the CA Fire Safe Council. A generous match for this application was committed to by CalFire to provide the Mt. Bullion Crew to assist our community if funds are received. YSRC&DC, CWPOA, Cascadel Mutual Water Company, Cascadel Firewise Committee and Cascadel Woods Fire Brigade also provided inkind match commitments.

Tree Removal Crews

The CCC Crews were back in the subdivision assisting with tree removal at the entrance of the subdivision, providing a safer ingress and egress. The crews cut dead trees along the road easements and split the rounds.

Split firewood was left alongside the entrance for community members to help themselves. Some residents, who were unable to get the wood to their home, requested the assistance of the CWPOA and friends. Six truckloads of wood has been delivered and in some cases stacked for the residents.

ACRT is working in the area to address pole replacement where lines are attached to standing dead trees.

ACRT is also marking more trees as of June 1 to be removed for PG&E. The crews for this round of removal will be by Trees Inc. They should be arriving by the third week of June.

Road Maintenance

No major roadwork is scheduled at this time; however, an update on any roadwork planned for fall/winter will be discussed at the September annual Member and Board Meeting.

Water Company News

As of April 15, the community returned to summer watering rules, which may be temporary.

The Board of Directors will discuss new California water restriction guidelines at the Board meeting on June 10, and possibly modify the current restriction policy accordingly.
