

Jess Coleman posted on our Cascadel Woods Residents Facebook Page confirming the incident. Jess continued to inform us of the helicopter being brought in to air lift the injured person to the hospital.

The helicopter was able to land in the mowed CSA field. It did have to lower down to the falls to retrieve the injured person.

Lindsey Weaver posted that Doug Gaiger was at the scene directing emergency traffic to the incident.

Toby Delaney posted; "I talked to his mom at the top of the Falls. He's an experienced hiker and had hiked the Falls many times. His wife was with him. He suffered a compound fracture".
