

On Saturday November 8 & 9, 2024 in Toulouse, France, Nate Hodges competed along with twelve other National Champions to claim the title, "STIHL TIMBERSPORTS® INDIVIDUAL WORLD CHAMPION".

#### **FIREWISE**

The application for 2024 recertification and the hours have been turned in to NFPA. CAL FIRE reviews applications of each Firewise USA Community, so it may take some time before we receive the results. We were required to have \$4,770 at \$31.80 per home, to qualify for recertification. We turned in a total of \$210,022 at \$1,400.15 per home. Even though some of the residents do not submit their hours, we have more than met our required amount of hours clearing, brushing, piling, thinning, burning, and hauling loads to the dump. Thank you all for helping to keep Cascadel Woods more safe in the event of wildfire. And thank you to all who did turn in your hours for the year and moneys spent on private contractor work to update your home with better fire resistant vents, windows, and roofs. This year we added Cascadel Heights into our Firewise USA Community. We are all in it together on this little mountain.

As soon as we are recertified, you will be sent a link to download the new certificate for your insurance providers.
